**Communique – Investments completed in the first semester of 2018**

The National Power Grid Company Transelectrica SA informs the interested public regarding the fact that in the first semester of 2018, investments amounting to 166 mill. LEI have been completed and put into operation, among their main goals are:

- Interconnection overhead line 400kV Reșița (Romania) - Pancevo (Serbia);
- Modernisation of substation 400/110/10 kV Cluj Est;
- Replacement of autotransformers (AT) and transformers in substations - Stage 2 - Lot I – Replacement of AT1 - 200 MVA from substation 220/110 kV Craiova Nord;
- Replacement of autotransformers and transformers in substations - Stage 2 - Lot I – Replacement of AT2 - 200 MVA from substation 220/110 kV Arefu;
- Modernisation of the command – control - protection system of substation 220/110/20 kV Sărdănești;
- Modernisation of substation 110 kV și 20 kV Suceava – Stage II: cells 110kV, cell 220kV AT - FAI, substation 20 kV;
- Installing optical fiber on the overhead line 220 kV Fundeni - Brazi Vest - lot 1;
- Connecting substations Turnu Măgurele, Mostiștea, Stâlp, Teleajen to the optical fiber grid of the National Power Grid Company Transelectrica SA - lot 2.
