Taking into account the provisions of art. 11 para. (5) of GEO no. 68/2019 on the establishment of measures within the central public administration and for the modification and addition of certain norms, published in the Official Gazette of Romania, Part I, no. 898/06.11.2019, according to which the exercise of the rights and the fulfillment of the obligations arising from the status of State shareholder at the National Power Grid Company Transelectrica SA is carried out by the General Secretariat of the Government,

Considering the topics included on the agenda of the Shareholders' Ordinary General Assembly from May 28/28, 2020, and the fact that the mandates of CNTEE TRANSELECTRICA SA Supervisory Board provisional members will run until May 29, 2020, and until the mentioned date the selection procedure cannot be finalised in accordance with the provisions of GEO no. 109/2011 on the corporate governance of public enterprises, with later amendments and additions, and the Methodological Norms approved by GD no. 722/2016,

Considering the provisions of art. 64<sup>1</sup> and of art. 64<sup>4</sup> of GEO no. 109/2011 on the corporate governance of public enterprises, with later amendments and additions,

I. The General Secretariat of the Government requests you, under art. 92 para.
