Important event to report: 2020 financial results

Transelectrica informs the investor public on the fact that on April 27, 2021, the Shareholders' Ordinary General Assembly of the Company met at 10.00 in Bucharest, str. Olteni no.2-4, district 3, "PLATINUM Center" building, 11th floor and issued Decision no. 1 by which: it did not approve the stand-alone financial statements of National Power Grid Company Transelectrica SA for the financial year 2020, the Company's consolidated financial statements for the financial year 2020, the distribution of the accounting profit after deducting the income tax on 31.12.2020, the distribution of dividends from the profit registered on 31.12.2020, the distribution of dividends from the retained earnings on balance as of 31.12.2020 and did not approve the discharge of the Directorate and Supervisory Board members for the financial year 2020, establishing the date of June 4, 2021 as the registration date of shareholders on whom the effects of the SOGA Decision will be reflected.

National Power Grid Company Transelectrica SA's stand-alone and consolidated financial statements at the date and for the financial year ended on December 31, 2020, mentioned above, together with the Annual Report and the Consolidated Annual Report were audited by the Company's External Financial Auditor, the opinion mentioned by it in the Audit Report being an unqualified opinion.

On March 24, 2021, the Company's Supervisory Board verified, within the limits of its powers, the Company's stand-alone and consolidated financial statements on the date and for the financial year ended on December 31, 2020, took note of the Independent Auditor's Reports on the Company's stand-alone and consolidated financial statements for the financial year ended December 31, 2020 and verified the Annual Report on the stand-alone financial statements as well as the Annual Report on the consolidated financial statements of the Company for the financial year ended December 31, 2020, on the same date took notice of the note regarding net profit distribution on 31.12.2020.

On March 25, 2021, in accordance with the Financial Reporting Calendar undertaken by law, Transelectrica published on the Company's website the documents subject to SOGA approval regarding the Company's 2020 activity. At the same time, on March 26, 2020, the meeting with financial analysts, investment consultants, brokers and investors took place, in order to present the 2020 results.
