Olteni 2-4, PLATINUM Center Building, 11th floor, Meeting room 1112, for all shareholders recorded in the Company's Shareholder Register at the end of April 08, 2022, initially published in Romania's Official Gazette 1147/18.03.2022, Part IV, and in the News of 18/20.03.2022, with the following item:
