Setting up the website page of Bucharest Subsidiary as information means for all stakeholders, pointing out the purpose of such professional organisation, and as communication platform with subsidiary members.

Eliminating the participation fees to the professional training sessions organised by Bucharest Subsidiary in cooperation with INPPI, deeming that such financial effort should be supported by the subsidiary's revenues, as a matter of fact constituted by the contributions of its members.

Organising cultural events dedicated to the Centennial of Romania's Union with outstanding guests from the academic environment and with historians who by their approach have pointed out the choice part of this profession.

Professional celebration of 20 years of regulated profession was organised, both for UNPIR and for Bucharest Subsidiary, by means of scientific and cultural events and bringing prominent representatives of all liberal professions, as recognition of the insolvency lawyer in economy and justice.

Permanent dialogue with subsidiary members in order to improve activities, detect practical problems, later transposed into by-laws changes and into the activity-incident legislation, which can expand the range of expenses that can be incurred or paid from the liquidation fund.

Signing and implementing the Protocol with DVBL sector 2 which granted access to the database of the Municipality Sector 2 in order to detect taxable goods held by insolvent companies.

Implementing the electronic file by cooperation with Bucharest Tribunal

Negotiating a protocol to be concluded with the Ministry of Internal Affairs, Directorate of Driving Licence Regimes and Motor Cars Registration, which will enable the insolvency lawyers' access to the database of DRPCIV in order to find the motor cars subjected to registration owed by insolvent companies. Completing and concluding this protocol is foreseen for 2021, when the secure communication requirements from STS have been implemented.
