Transelectrica, the Romanian Transmission System Operator, operates and monitors the activity of 3 types of markets: Balancing Market, Ancillary Services Market and Market for Allocation of Cross-Border Capacities.

Using the records from the markets data base, Transelectrica prepares daily, weekly and monthly monitoring reports. A part of the data included in these reports (those data which are not confidential) is published on the website **www.transelectrica.ro**



- On the Bulgarian border, the daily allocation is of implicit type as a result of the integration of RO – BG border in Single Day-Ahead Market Coupling (SDAC). In case of decoupling, the Joint Allocation Office (JAO) is the organizer of the explicit daily auctions (shadow auctions) for RO – BG border. Implicit intraday allocation with continuous trading is organized on the Bulgarian border, as a result of the integration of Romanian intraday market in SIDC (Single Intra-Day Market) and starting with 01.10.2022 was launched the 15 minutes cross-border product. In the event of decoupling, no explicit intraday auctions are organized on RO – BG border.
- On the Hungarian border, the daily allocation is of implicit type as a result of the integration of RO – HU border in Single Day-Ahead Market Coupling (SDAC). Starting with 08.06.2022 (for the delivery day 09.06.2022) the Flow - Based Day - Ahead Market Coupling was launched across the whole Core region (including the RO – HU border), thus optimizing the energy exchange between the bidding zones within the region. In case of decoupling, the Joint Allocation Office (JAO) is the organizer of the explicit daily auctions (shadow auctions) for RO-HU border. Implicit intraday allocations are held with continuous trading, as a result of the integration of Romanian intraday market in SIDC (Single Intra-Day Market). On this border the 15 minutes cross-border product is available. In the event of decoupling, no explicit intraday auctions are organized on RO – HU border.
- The long term auctions on Hungarian and Bulgarian borders are held by Joint Allocation Office (JAO) based on Allocation Rules for Forward Capacity Allocation (HAR) and border specific Annex. On these borders it is applied:
 - ✓ reservation of a percentage of interconnection capacity for short term auction, offered capacity being calculated as 80% of the minimum of available capacities of all periods of the month;
 - ✓ starting with July 2022, at the monthly auctions on the Hungarian border, Physical Transmission Rights have been replaced by Financial Transmission Rights (allocated capacity is no longer a physical right that can be used by the participant, but it is only a financial right).
- On the Serbian border, the bilateral coordinated allocation is done for 100% of total capacity: daily auctions are held by EMS (Serbia) and long term and intraday auctions are held by Transelectrica. The intraday allocation is done in six auction sessions for time intervals: 00:00-04:00, 04:00-08:00, 08:00-12:00, 12:00-16:00, 16:00-20:00, 20:00-00:00 CET.
- Allocation of Physical Transmission Rights and UIOSI („use it or sell it”) principle are applied on the Bulgarian and Serbian borders.



- Long term auctions (yearly and monthly) are currently suspended on the Ukrainian – Romanian border, only unilateral daily auction being organized (until the coordinated allocation rules are agreed, the Ukrainian TSO held a pre-allocation, an prior auction to the auction organized by Romanian TSO).
- On the Moldavian border, the bilateral coordinated daily allocation for 100% of total capacity was introduced starting with 11.10.2022 for the delivery day 12.10.2022, auctions being organized by Transelectrica. Currently there are no long term auctions held on the Moldavian border.
- The “netting” principle is applied to NTC based daily and intraday allocation.
- The physical transmission rights are used (nominated) in accordance with „m:n” nomination principle;
- Transelectrica’s auctions are held on Damas platform, with euro currency trading;
- Daily auction results on the Serbian border (auction prices, allocated capacities) are provided by the Serbian TSO and long term auction results on the Hungarian and Bulgarian borders are provided by JAO;
- Monthly auctions for October were held as:
 - ✓ import/export Hungary, import*/export Bulgaria, during the period 01 – 31.10.2022;
 - ✓ import Serbia, during the periods 01 – 16.10.2022; 17 – 21.10.2022; 22 – 23.10.2022; 24 – 28.10.2022; 29 – 30.10.2022; 31.10.2022;
 - ✓ export Serbia, during the periods 01 – 07.10.2022; 08 – 09.10.2022; 10 – 21.10.2022; 22 – 23.10.2022; 24 – 28.10.2022; 29 – 31.10.2022.

* according to the allocation rules, monthly offered capacity was calculated taking into account the minimum of NTC's monthly values.


























