According to the Commercial Code, Transelectrica, the Romanian Transmission System Operator, operates and monitors the activity of 3 types of markets: Balancing Market, Ancillary Services Market and Market for Allocation of Cross-Border Capacities.

Using the records from the markets data bases, Transelectrica prepares daily, weekly and monthly monitoring reports. A part of the data included in these reports (those data which are not confidential) are published on the website www.transelectrica.ro (section Transparency).

General Remarks

- The contracts signed between the Ancillary System Services Suppliers and Transelectrica covered 95.52% from TSO's necessary volume.
- The report contains requested quantities by Transelectrica (through NDC), contracted quantities based on bid amounts and realized quantities.
- 8 participants have supplied Ancillary Services: CE Hunedoara S.A., CE Oltenia S.A., Hidroelectrica S.A., Bepco S.R.L., Electro Energy Sud, Electrogrup S.A., Nova Gas&Power S.A., Electrocentrale Craiova S.A.
- Transmission network losses have been contracted through CMBC market with: Complexul Energetic Oltenia (C326/2021), GEN-I (C369/2021), Hidroelectrica (C409, C410, C411, C417, C418/2021, C661/2022), LJJ GSE Gamma (C651/2022), Nuclearelectrica (C583/2022), Termoficare Oradea (C777/2022), total contracted quantity includes also the energy traded by Transelectrica on DAM, IDM and BM.

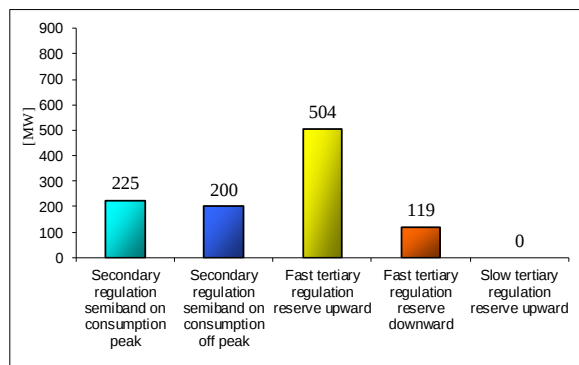

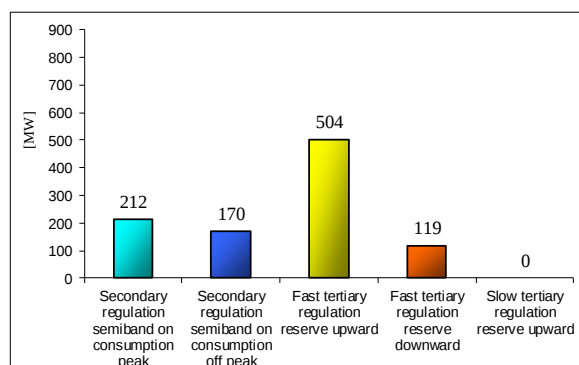

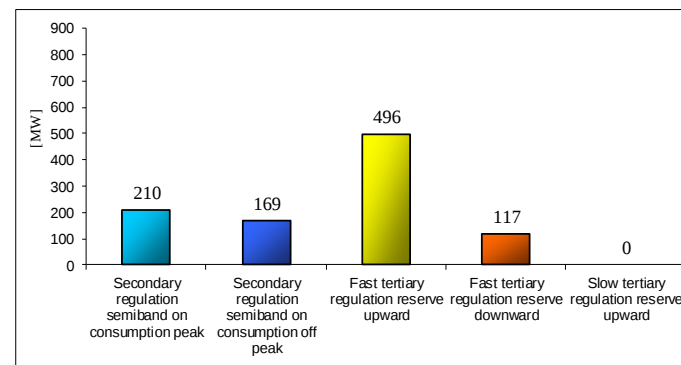
Average requested quantities [hMW/h]



Average contracted quantities [hMW/h]



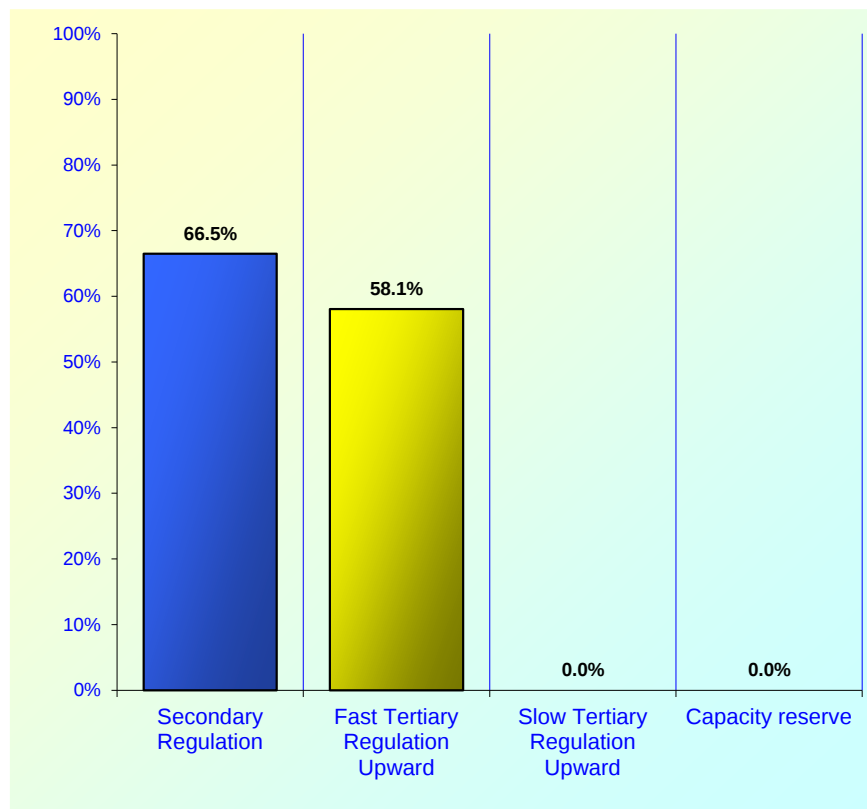
Average realized quantities [hMW/h]



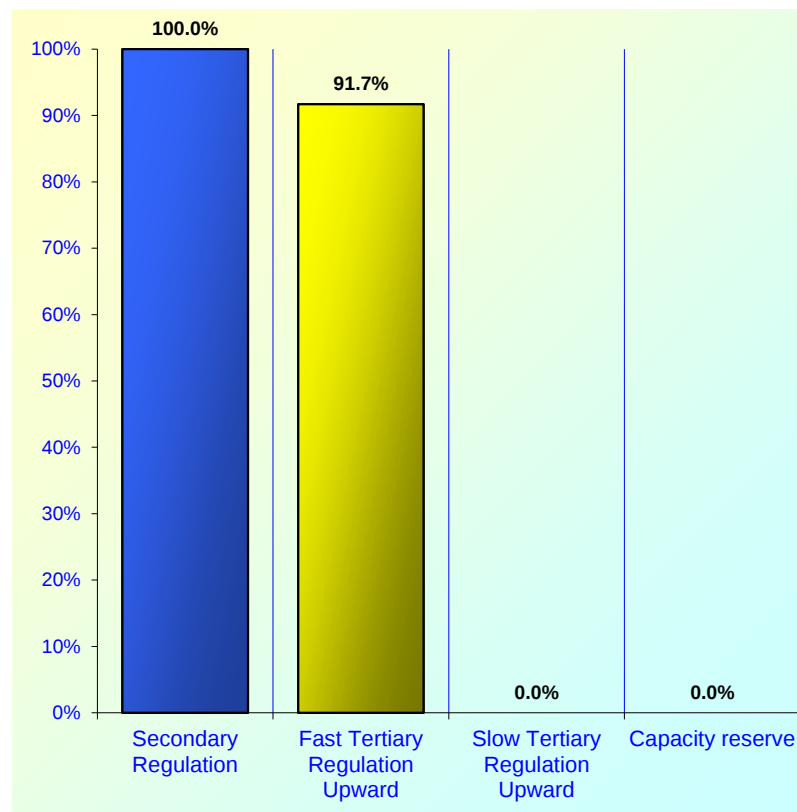
In December 2022, Ancillary Services contracts were concluded as a result of daily tenders organized by C.N.T.E.E. Transelectrica S.A. Necessary quantities to be purchased for Secondary Band Reserve and Upward Fast Tertiary Reserve remained at the level of the previous month, while necessary quantities for Downward Fast Tertiary Reserve slightly increased, against the background of winter holidays. In the case of Slow Tertiary Reserve, no tenders were held.

C1 (%) on type of regulation



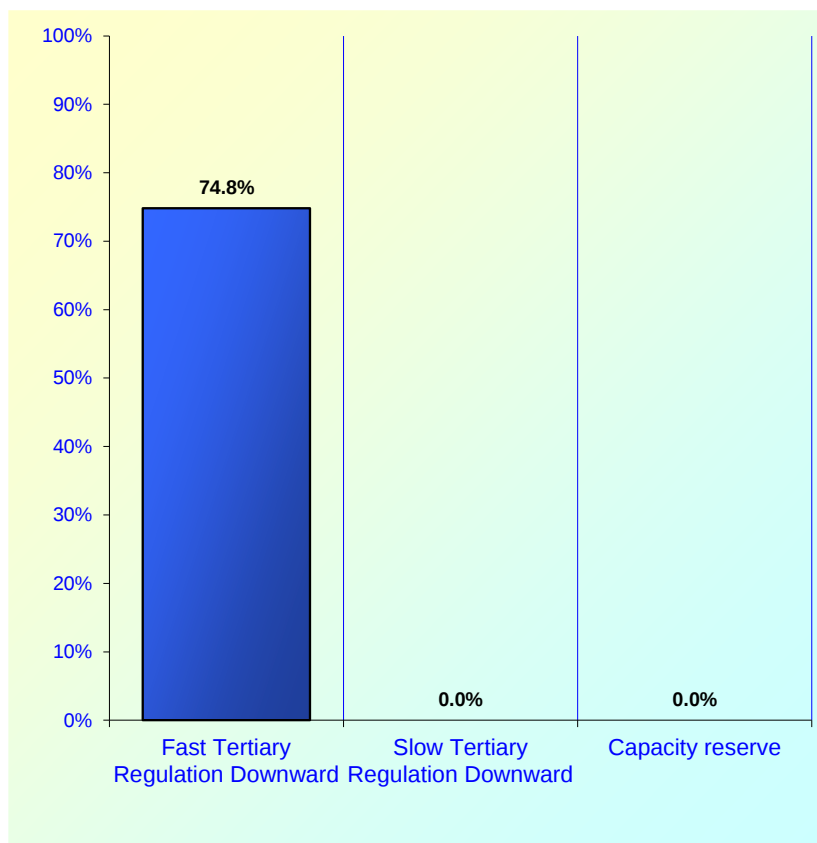
C3 (%) on type of regulation



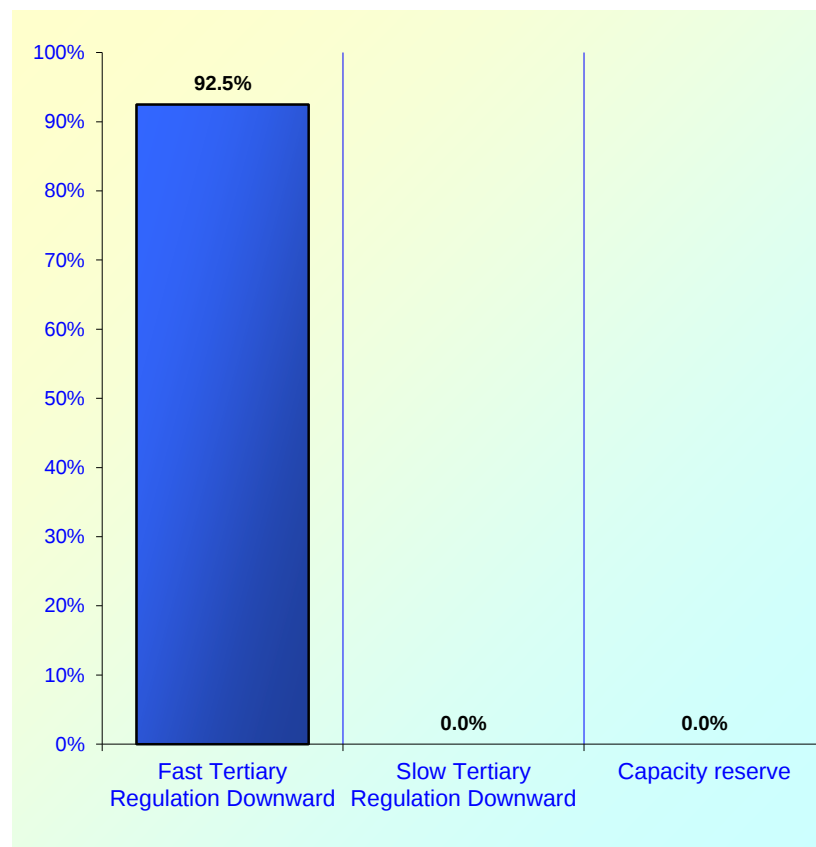
