Request to complete the agenda of the Shareholders' General Ordinary Assembly of NPG Transelectrica, convened for June 19/20, 2023

#### Dear Sirs,

taking into consideration the provisions of:

- art.11 para. (5) from G.E.O. no. 68/2019 regarding the setting of some measures on the central public administration level and in order to amend and add some legislation according to which the exercise of rights and the fulfillment of the obligations arising from the quality of state's shareholder at the NPG Company Transelectrica is performed by the Government's General Secretariat;
- art. 105 para. (3) of Law no.24/2017 on issuers of financial instruments and market operations, republished, in conjunction with the provisions of art 117<sup>1</sup> from the Corporations Law no. 31/1990, republished with later amendments and additions,

and taking into consideration the items included on the agenda of The Shareholders' Ordinary General Assembly from June 19/20, 2023 and the fact that on June 21, 2023 the mandates of the provisional members of the Supervisory Board expire and that until the date mentioned the selection procedure cannot be completed in accordance with the provisions of G.E.O. No. 109/2011 *regarding corporate governance of public enterprises*, with later amendments and additions and the Methodological Norms approved by G.D. no. 722/2016,

in relation to the provisions of art.  $64^4$  from G.E.O. no. 109/2011 with later amendments and additions,

I. The Government's General Secretariat requests that you shall add to the agenda of The Shareholders' Ordinary General Assembly convened for June 19/20, 2023, the following items:

Based on those mentioned above, we request that you shall take all measures to give access to the shareholders to all the materials necessary in order to take some decisions, in accordance with what was requested and submitted, by covering the publication procedure in accordance with the regulations in force on the capital market.

We also attrached the requested documents to submit the candidacy for the persons mentioned above, as it follows:

- Copy of the identity document signed in accordance with the original one by the holder of the identity document;
- Curriculum vitae, updated, European model;
- Statement on one's own responsibility regarding the lack of criminal history;
- Statement on one's own responsibility regarding the non-enrollment on the list that includes the administrators whose mandates were revoked for reasons imputable to them;
- Statement on one's own responsibility regarding non-conflict of interest;
- Statement on one's own responsibility mentioning if they hold or not the status of 'independent' within the meaning of the provisions of art. 138<sup>2</sup> of Law no. 31/1990 regarding corporations, republished with later amendments and additions;
- Statement on one's own responsibility if the person is currently employed within a public institution;
- Declaration of consent for the processing of personal data.
