The National Power Transmission Company Transelectrica informs the investing public on the fact that the rating agency **Moody's Investors Service** has **reconfirmed** on August 29, 2024 **the rating of C.N.T.E.E. Transelectrica S.A. at "Baa3" for the long term debt as well as and the stable outlook.**

Transelectrica credit quality ("Baa3"- "investment-grade") is supported by the low risk profile of the Company, as the only operator that provides the electricity transmission service in Romania, the consistent implementation of key principles within a regulatory regime that supports credit, of a robust financial profile, low debt and strong financial values.

We mention that the Company's rating is the same as the rating granted to the Romanian Government (stable Baa3).
