- Coordinates and controls the implementation of investment and rehabilitation activities of the county infrastructure.
- Collaborates with the Prefect of Ialomița County in emergency or force majeure situations, as vice – president of the committee for emergency situations.

- Submits to the local council suggestions to establish public facilities, commercial companies and public services of local interest;
- Submits to the local council the cooperation or association with other local public administration authorities in the country or abroad, as well as joining national and international associations of local public administration authorities, in order to promote common interest.
