(1) of Corporations Law no. 31/1990, republished with later amendments and additions and art.18 para. Changes in the Directorate in the year 2024:

Pursuant to art. III of Law no.187/2023 regarding the change and addition of Government Emergency Ordinance no. 109/2011 on corporate governance, through SB resolution no. 39/24.10.2023 the following are appointed as provisional members of Directorate with a mandate starting 25.10.2023, for five months until 24.03.2024: Ştefăniță MUNTEANU –Directorate chairman, Cătălin Constantin NADOLU, Florin Cristian TĂTARU and Bogdan TONCESCU;
Pursuant to art. III of Law no.187/2023 regarding the change and addition of Government Emergency Ordinance no. 109/2011 on corporate governance of public enterprises, with later additions and amendments, an extension for two months of provisional members mandates from 25.03.2024 until 25.05.2024 was decided for the followings: Ştefăniţă Munteanu, Cătălin Constantin Nadolu, Florin Cristian Tătaru and Bogdan Toncescu, but not later than the end of selection procedure according to GEO 109/2011 provisions if it shall be made during this time interval;
On May 24, 2024 the Directorate provisional members mandates ended by reaching expiration time and the followings were appointed as provisional members of Directorate: Ştefăniță Munteanu, Cătălin Constantin Nadolu, Florin Cristian Tătaru and Bogdan Toncescu, for a five - months mandate starting 25.05.2024 but the mandate shall not be later than the end of selection procedure for Directorate members according to GEO 109/2011 provisions on corporate governance of public enterprises, with later additions and amendments if the procedure shall end in this time interval;
In accordance with its statutory and legal duties, taking into consideration the candidates recruitment and selection final report for Directorate member position in Transelectrica, the following were appointed as members of Directorate since 3.10.2024: Florin-Cristian Tătăru, Victor Moraru, Ștefăniță Munteanu, Cătălin-Constantin Nadolu and Vasile-Cosmin Nicula. The appointment was made in accordance with the provisions of art. 35 para. (4)-(8) and (11) of GEO 109/2011 on corporate governance of public enterprises, as a result of selection procedure for the positions of Directorate members of Transelectrica pursuant to art. 23 from Articles of Association;
pursuant to art. 23 para (1) from Articles of Association of Transelectrica, the Supervisory Board elected Ştefăniță MUNTEANU as chairman of Directorate, also called Executive Director General or Chief Executive Officer – "CEO" of National Power Transmission Company Transelectrica. The time period of mandate for Directorate members is from 3.10. 2024 until 29.02.2028.
