- The request of Government General Secretariat number FN/9.12.2025 recorded at AMEPIP under the number 13368/9/12/2025 through which, pursuant to Law 158/2025, the updated key performance indicators (ICP) contained in the Administration Plan of National Power Transmission Company Transelectrica for years 2024-2028, were sent;
