

Transelectrica, the Romanian Transmission System Operator, operates and monitors the activity of 3 types of markets: Balancing Market, Ancillary Services Market and Market for Allocation of Cross-Border Capacities.

Using the records from the markets data base, Transelectrica prepares daily, weekly and monthly monitoring reports. A part of the data included in these reports (those data which are not confidential) is published on the website **www.transelectrica.ro**

General Remarks

- According to the agreements between Transelectrica and neighbors for year 2019 :
 - ✓ on the Bulgarian border, the bilateral coordinated allocation is done for 100% of total capacity by Transelectrica for daily auctions where the “netting” principle is applied. Starting with 01.01.2015, intraday auctions are no longer organized on the Bulgarian border, since the Bulgarian market rules are not allowing intraday cross-border exchanges and modifications of the notified schedules after 15:30 (CET) in D-1 for day D.
 - ✓ on the Hungarian border, the bilateral coordinated allocation, is done for 100% of total capacity by Transelectrica for intra-day auctions. Implicit daily allocations are held since the CZ-SK-HU-RO day-ahead market coupling. In the event of decoupling, MAVIR is in charge with the explicit daily auctions (shadow auctions) for RO-HU border. The “netting” is applied to daily and intra-day allocation.
 - ✓ on the Serbian border, the bilateral coordinated allocation, is done for 100% of total capacity by EMS (Serbia) for daily auctions and by Transelectrica for long term and intra-day auctions. The “netting” is applied to daily and intra-day allocation.
 - ✓ *UIOSI* („use it or sell it”) principle is applied on Hungarian, Bulgarian and Serbian borders.
 - ✓ starting with 01.01.2019, the long term auctions on Hungarian and Bulgarian borders are held by Joint Allocation Office (JAO) based on Allocation Rules for Forward Capacity Allocation (HAR) and border specific Annex. On these borders it is applied:
 - ✓ reservation of a percentage of interconnection capacity for short term auction, offered capacity being calculated as 80% of the minimum of available capacities of all periods of the month;



- Transelectrica's auctions are held on Damas platform, with euro currency trading;
- On Romania – Bulgaria, Romania – Serbia and Romania – Hungary border, the use of the physical transport rights is performed in accordance with the m:n nomination principle, for all time horizons.

General Remarks

- Long term auction results on the Hungarian and Bulgarian borders are provided by JAO and daily auction results on the Serbian border (auction prices, allocated capacities) are provided by the respective TSO.
- The intra-day allocation is done in six auction sessions for time intervals: 00:00-04:00, 04:00-08:00, 08:00-12:00, 12:00-16:00, 16:00-20:00, 20:00-00:00 CET.
- Usage of allocated capacity on Ukrainian and Moldavian border is restricted by Ukrainian TSO agreement and respectively by the approval of the distribution operator of the passive consumption islands.
- Monthly auctions for February 2019 were held as: import/export Hungary*; import/export Bulgaria*; import/export Serbia and import/export Ukraine for the period 01.02 – 28.02.2019.
- In February 2019 there were no auctions held on Moldavian border.

* according to the allocation rules, monthly offered capacity was calculated taking into account the minimum of NTC's monthly values.













Usage Level of Intraday Allocated Capacity






Usage Level of Allocated Capacity



Usage Level of NTC on Romanian – Hungarian border








