Taking into account the provisions of article 92 of Law 24/2017 regarding issuers of financial instruments and market operations, corroborated with the provisions of article 117¹ of Company Law 31/1990, republished, with later amendments and additions,

Taking into account the items included in the agenda of Shareholders' General Ordinary Assembly of 13/14.05.2019, published in accordance with applicable legal provisions, we can inform you as follows:

We request adding the agenda of the AGOA reunion with the following items:

- Appointing provisional members in the Supervisory Board of CNTEE Transelectrica SA, beginning with 30.05.2019;
- Establishing a four month term for the mandates of provisional Supervisory Board members;
