The National Power Grid Company Transelectrica SA informs the shareholders and investors that on 01.01.2020 became effective the Addendum 6 to contract C256/01.07.2014 “*Maintenance services and operation of telecommunication, process and information technology systems*” concluded with the subsidiary Company for Telecommunication and Information Technology Services to Electricity Transmission Networks TELETRANS SA as provider.

The changes operated following concluding the Addendum are as follows:	
Deed conclusion date and type	Addendum 6 to C 256/2014 concluded on 23.12.2019.
Describing the addendum object	Extending with 6 months the contract C256/2014, namely until 30.06.2020 without increasing the contractual value by redistributing the achieved savings, the total price being 120,000.00 Lei spread out for 01.01.2020 – 30.06.2020.
Guarantees constituted	The Provider is obliged to reconstitute the performance bond of the contract amounting to 5% from the addendum value for the extension interval 01.01-30.06.2020, VAT free, namely 6,000 Lei into an account opened to the contracting authority's disposal at the State Treasury unit of the competent fiscal body. The amount constituted as performance bond for 01.01-30.06.2020 will be returned within 14 days from the Provider's achievement of contractual obligations assumed, unless the Purchaser has had any claims on the bond until then.
