REPORT

of the Nomination and Remuneration Committee from the Supervisory Board of National Power Grid Company Transelectrica SA ("Company") regarding the remunerations of supervisory board's and directorate's members in the financial year 2019

Section A - SUPERVISORY BOARD

1. Legal framework regarding the remuneration policy and criteria for non-executive administrators - the Supervisory board

In accordance with the general legal framework as per article 111 para. (2) lett. c) of Company Law 31/1990, republished, with later amendments and additions, the competence to set the remuneration of supervisory board members belongs to the Shareholders' general assembly ("AGA").

The Company is a public enterprise in accordance with article 2 item 2 lett. b) of Emergency Ordinance 109/2011 regarding the corporate governance of public enterprises, with later amendments and additions (GEO 109/2011). GEO 109/2011 regulates the specific conditions for the remuneration of members in the supervisory board of a public enterprise.

In 2019, the following changes occurred in the **Supervisory Board's membership**:

- on <u>01.01.2019</u> the Supervisory Board members were as follows: Gheorghe Olteanu, Ion Ciuculete, Liviu Ilaşi, Adrian Mitroi, Alin-Sorin MITRICĂ, Fănel Mihalcea and Constantin Dumitru.
- AGA Decisions no. 4, 5, 6, 7, 8, 9 and 10/29.03.2019 appointed, beginning with 30.03.2019, the following Supervisory Board members: Adrian Mitroi, Alin-Sorin MITRICĂ, Constantin Dumitru, Mihaela Toader, Mihaela Constantinovici, Mircea Coşea and Nina Carmen Crişu, their mandate ending on 29.05.2019.
- by Supervisory Board Decision no. 14/08.04.2019, the non-acceptance of the mandate by Nina Carmen Crişu is noted, appointed by AGA Decision no. 10/2019 and Florin Ciocănelea is appointed as provisional member, his mandate ending on <u>29.05.2019</u>.





- AGA Decision no. 14/14.05.2019 appointed, beginning with <u>30.05.2019</u>, the following Supervisory Board members: Adrian Mitroi, Alin-Sorin MITRICĂ, Constantin Dumitru, Mihaela Toader, Mihaela Constantinovici, Mircea Coșea and Florin Ciocănelea, their mandate ending on 29.09.2019.
- AGA Decisions no. 16, 17, 18, 19, 20, 21 and 22/20.09.2019 appointed, beginning with 30.09.2019, the following Supervisory Board members: Adrian Mitroi, Petru Tarniceru, Ionică Bădilă, Mihaela Toader, Mihaela Constantinovici, Mircea Coșea and Florin Ciocănelea, their mandate ending on 29.11.2019.

- by Supervisory Board Decision no. 81/13.12.2019, the non-acceptance of the mandate by Manuela Stan Olteanu is noted.
- by Supervisory Board Decision no. 88/18.12.2019, the resignation of Sebastian Burduja is noted.

2. Contractual framework for the remuneration of non-executive administrators - the Supervisory Board

The Supervisory Board members benefit of a fixed gross monthly remuneration, set by the shareholders' general assembly, in accordance with the applicable legal provisions.

Until 29.11.2019, the maximum fixed gross monthly indemnification owed to Supervisory Board members during the provisional members' mandate was established by the AGA Decision no. 3/05.03.2018, in quantum of 5,319 lei gross/month.

Starting with 30.11.2019, the maximum fixed gross monthly indemnification owed to Supervisory Board members during the provisional members' mandate was established by the AGA Decision no. 31/26.11.2019, in quantum of 13,976 gross lei/month.

The mechanism granting the fixed gross monthly indemnification is as follows:

- The Supervisory Board chairman and SB members being active in at least 2 consultative committees of the board benefit of maximum fixed monthly indemnification;
- Supervisory Board members being active in a consultative committee of the board benefit of fixed monthly indemnification representing 90% of the maximum fixed monthly indemnification;
- Supervisory Board members who are not active in the consultative committees of the board benefit of fixed monthly indemnification representing 85% of the maximum fixed monthly indemnification.

In accordance with the applicable legal and contractual provisions, the amounts for the fixed remuneration owed to Supervisory board members calculated in 2019 are provided in the following table (sums provided in gross monthly amounts). Provisional Supervisory board members do not benefit of variable component in their remuneration.

In accordance with the general legal framework as per article 153^18 para. (2) of Company Law 31/1990, republished, with later amendments and additions, the competence to establish the remuneration of directorate members belongs to the supervisory board.

GEO 109/2011 regulates the specific conditions for the remuneration of directorate members in a public enterprise.

In 2019, the following changes occurred in the **Directorate's membership**:

2. Contractual framework regarding the remuneration of executive administrators - Directorate

In accordance with the mandate contracts concluded between the Company and the Directorate members, they benefit of remuneration consisting of fixed gross monthly indemnification and do not benefit of variable component.

In 2019, the Directorate members had a fixed gross monthly indemnification, established by the Supervisory Board in accordance with the legal provisions in force, as follows:

- Directorate Chairman indemnification -33,200 lei gross/month;
- Directorate members indemnification -31,600 lei gross/month.

In accordance with the legal and contractual provisions applicable on 31.12.2018, the amounts corresponding to the fixed and variable remuneration owed to Directorate members calculated for 2019 are provided further. Provisional Directorate members do not benefit of variable component in their remuneration.
