According to the Commercial Code, Transelectrica, the Romanian Transmission System Operator, operates and monitors the activity of 3 types of markets: Balancing Market, Ancillary Services Market and Market for Allocation of Cross-Border Capacities.

Using the records from the markets data bases, Transelectrica prepares daily, weekly and monthly monitoring reports. A part of the data included in these reports (those data which are not confidential) are published on the website www.transelectrica.ro (section Transparency).

General Remarks

- Considering the provisions of art. 6 paragraph (9) of Regulation (EU) 2019/943 of the European Parliament and of the Council of 5th of June 2019 on the electricity market, starting with February 2020, CNTEE Transelectrica S.A. conducts daily auctions for the acquisition of ancillary services.
- The contracts signed between the Ancillary System Services Suppliers and Transelectrica covered 100% from TSO's necessary volume.
- The report contains requested quantities by Transelectrica (through NDC), contracted quantities based on ANRE decisions, bid amounts and realized quantities.
- 11 participants have supplied Ancillary Services: CE Hunedoara S.A., CE Oltenia S.A., Hidroelectrica S.A., SC Romgaz S.A., Electrocentrale Galati, SC Bepco S.R.L., Electro Energy Sud, SC Electrocentrale Bucuresti S.A., OMV Petrom S.A., SC Veolia Energie Iasi, Veolia Energie Prahova.
- Transmission network losses have been contracted through CMBC market with: Electromagnetica SA (C959/2019), ENGIE Romania (C807, 808/2019), Entrex Services (C789, C854/2019), GEN-I doo (C763, C780/2019), Monsson Trading (C873/2019), Renovatio Trading (C790, C791/2019), SN Nuclearelectrica (C434/2018), Tinmar Energy (C765/2019), total contracted quantity includes also the energy traded by Transelectrica on DAM, IDM and BM.

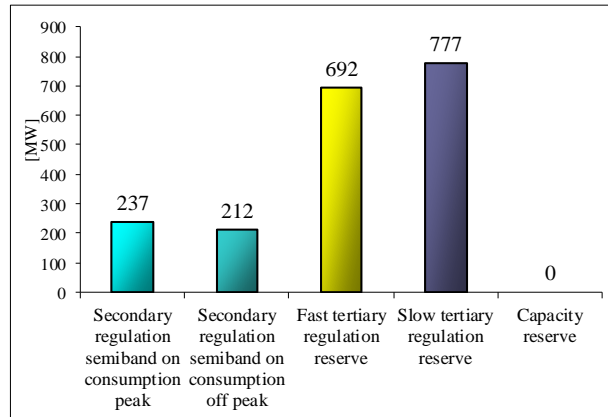

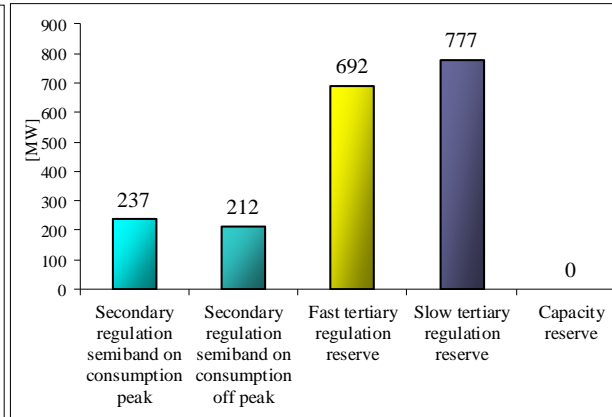

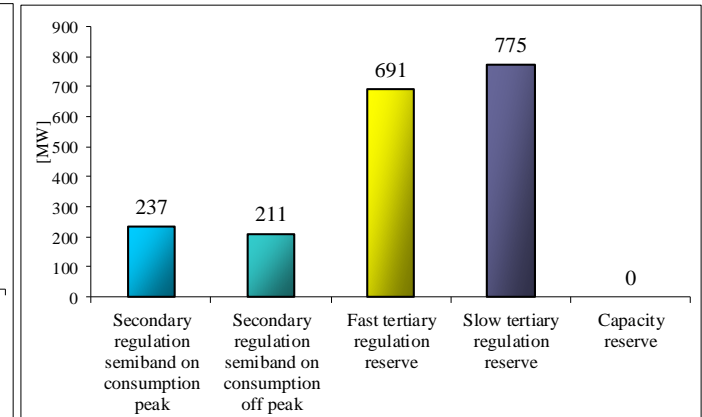
Average requested quantities [hMW/h]

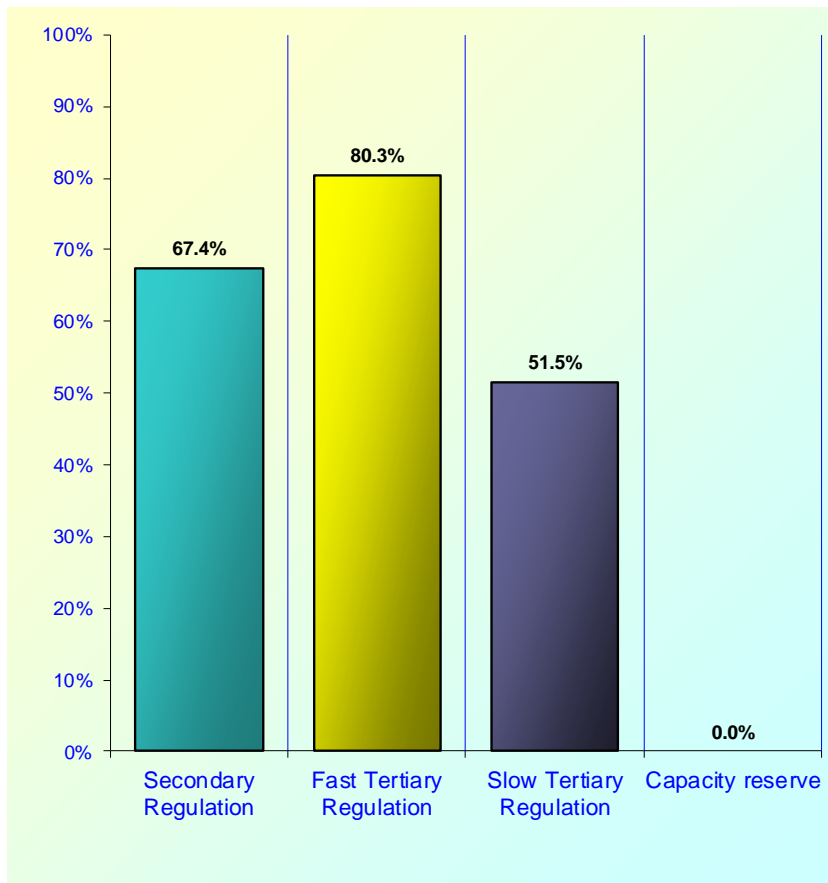

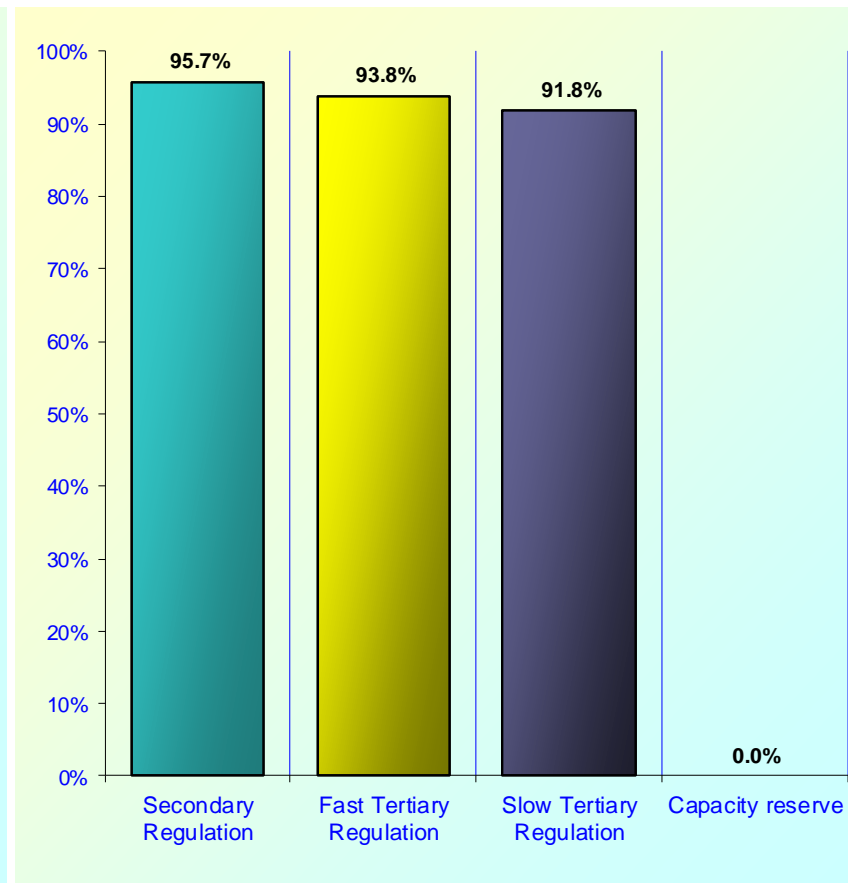

Prices on organized auctions in February 2020 for the secondary regulation were between 60 lei/hMW and 500 lei/hMW, in most time intervals (64.51%) of the month the price was 80 lei/hMW. The price of 500 lei/hMW is registered in a single time interval (12th of February, int. 1), and the price of 200 lei/hMW in other two time intervals (7th of February, int. 1. and 13th February, int. 1).
